Physician Recruitment	<ul style="list-style-type: none"> • Negotiating with Dr. Watson to be an employee of the district. Putting together his contract. Looking at \$60,000 medical director services (Acute, ER, SNF, EKG) We will be able to get some cost reimbursement. We will offer a flat rate for reading EKG's. Will be required to attend at least 6 BOD meetings. He will be at all Quality meetings. \$60,000 inpatient rounding; we will bill for this service. We would be able to bill almost double if we were an RHC as opposed to billing as a hospital. We will be putting together options (Merger, partnership, competition to present to MVHC) • We have been working on recruiting a NP who has been working in a CAH. Preliminary job offer has been extended. The terms have verbally been accepted. He would start in early February and work about 10 days per month. NP's can work independent from a physician. Med Staff by-laws have been changed to allow for mid-levels. • Schedule would likely be Watson – 9 days – NP – 5 days Dahle – 9 days– NP – 5 days • MMHD will be billing for inpatient and SNF. Ward has let Dave Jones at MVHC know we will be doing this. • Lakey worked with Partnership on the rates. We have amended the contract so we can bill. It will be about \$40-50 per visit. We will be at a loss under the current structure, but will have options and some control to make necessary changes. • MVHC hired Dr. Babs in Burney clinic. He doesn't have the experience level to help the hospital - hasn't completed residency. • Ward will meet with a husband/wife physicians on January 16th. 	Discussion

SEMSA Update	<ul style="list-style-type: none"> Met with SEMSA on December 20 as a group (SEMSA employees, our EMS staff and Administration and some ER nurses.) The big question was how it would directly impact employees. Went over pay scale. Most EMS would see between a \$9-12,000 annual increase. Employees would keep seniority with SEMSA. SEMSA PTO is better than ours. 401k with a 6% match Everyone left the meeting with a positive tone. Staff should send questions directly to Administration or SEMSA DRAFT contract was distributed. There are several items that need to be modified. There is discussion of SEMSA building a new helipad at MMHD Questions about the aviation insurance. Ward would like to do a town hall to introduce SEMSA to the community. EMS will participate. (January) Final contract in January 	Discussion
